I understand that while using the facilities at the **DUNSMUIR ROD & GUN CLUB** I am solely responsible for my conduct and safety and for those persons I bring to the range. I understand that Membership in the Dunsmuir Rod & Gun Club is a family membership and that all family members have certain responsibilities. If I or a family member gives the combination to the gate to a non-member, I assume full responsibility for any damage or injuries they may cause or incur.

**I understand that guests must be accompanied by a member that is at least eighteen of age.**

I acknowledge that the operation and use of the firearms has inherent risks, hazards and dangers that cannot be eliminated. I understand that these risks, hazards and dangers include without limitation to:

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of injury from ammunition and shot from your firearm and the firearms of others.

I understand that I have the responsibility to follow the instructions and warnings of firearms and ammunition manufacturers and to ensure that my firearms and ammunitions are in safe working order. I have the responsibility to have the degree of skill and knowledge necessary for me to engage in these activities. I for myself, my heirs, successors, executors and subrogees, hereby knowingly and intentionally waive and release, indemnify and hold harmless the **DUNSMUIR ROD AND GUN CLUB**, their officers, directors, agents, members and volunteers from any and all claims, actions causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to , arise out of, or are connected with this activity including but not limited to, negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss injury, paralysis or death to me or my property as a result of my engaging in these activities.
